



Fondazione Guglielmo Marconi – Marconi Institute for Creativity

Postdoctoral Scholarship

I

The Fondazione Guglielmo Marconi opens applications for the assignment of a Postdoctoral scholarship for research activities with reference to the projects of the Fondazione Guglielmo Marconi - Marconi Institute for Creativity, and in particular to the project funded by European Commission FP7 - ICT Call 10 - **CReativity Enhancement through Advanced brain Mapping and stimulation - CREAM**, for the following activities: **Requirements for the analysis, measurement, and stimulation of creativity.**

II

The selection is open to candidates who possess the following qualification:

- Ph.D. in Psychology

Candidates must possess the application requirements on the date of expiry of the present opening of application document. Participation is open exclusively to applicants who are in possession of a Ph.D. at an Italian University, or possess an equivalent qualification from a foreign university.

It is also required:

- Experience in the science of creative thinking
- Proficiency in English (verified during the selection interview)

The scholarship cannot be combined with research grants or any other scholarship, or with salaries from employment relationships, including temporary contracts.

The activity of the fellow must be performed uninterruptedly. Unwarranted interruptions of the research activities give right to the Fondazione Guglielmo Marconi to terminate the collaboration. The scholarship grant may be suspended if requested by the collaborator in case of maternity or serious and documented illness with more than 30 days prognosis, provided that the period of suspension must be made up.

III

The scholarship is for 11 months. The gross total amount of the scholarship grant is worth € 28,000.00 (twenty eight thousand euro/00), including any taxes and social security contributions paid by the fellow. The grant will be provided with monthly payments.

The research program will be developed under the supervision of a responsible person designated by the Fondazione Guglielmo Marconi - Marconi Institute for Creativity.

At the end of the scholarship period, the fellow must submit a scientific report about her/his activities.

IV

V

In the application the candidate must indicate:

- Personal details, date and place of birth, fiscal code, residence and domicile address for the purposes of the scholarship, telephone number;
- The University where the degree was awarded, the discipline of the degree, the title and the main subject of the thesis, the presenter's name, the date and the discussion session, the final grade
- The graduation of PhD in psychological disciplines;
- To have no prior criminal convictions and have no criminal proceedings underway (otherwise, please specify);
- Any other qualifications

The candidate must also add to application:

- A copy of the Ph.D. thesis,
- The scientific-professional curriculum,
- Copies of publications,
- Any other documents or certificates if considered useful.

VI

The commission is composed by the President of the Fondazione Guglielmo Marconi, the President of the Scientific Committee of the Fondazione Guglielmo Marconi, and a third member designated by them.

The interview will be held on December 17, starting at 15:00, at the Fondazione Guglielmo Marconi, via Celestini 1, 40037 Pontecchio Marconi (Bologna, Italy). In the case of foreign applicants, the interview may be held through teleconference on the same date and time. Foreign applicants shall provide teleconference contacts (Skype id, cellular phone number) by indicating it in their application.

VII

The winner will be given notification of the award of the scholarship by registered letter. The document will also indicate the day in which the activities will start.

Within 15 days from the day of receiving the document, the fellow must send to Fondazione Guglielmo Marconi, via Celestini 1, 40037 Pontecchio Marconi (Bologna, Italy) a statement of acceptance with the commitment to start the work on the day indicated in the communication note.
